


ABOUT BCAQ

During the 2022-2023 year, our Octopus team was fortunate to rely on its members, Board of Directors, and a dedicated but small workforce committed to our mission!

The year 2022-2023 was particularly moving and provided a wonderful opportunity to reflect on our internal organizational habits and succession planning. In doing so, we once again clarified our intentions for collaboration, analysis, and prevention through an intersectional approach.

Collaborations, Dialogues, and Important Advocacy

The year was marked by significant collaborations and a collective success in defending rights, culminating in our involvement in the fight for a substantial modernization of the Canadian Environmental Protection Act with our allies in Quebec and Canada (mobilizations, presentations, memoranda, federal political meetings). BCAQ has been advocating for the strengthening of this law, particularly its regulation of toxic substances, for years, and significant progress has certainly been made. However, we will remain vigilant regarding its implementation. Dialogues and political contacts at the provincial level have solidified the legitimacy of our organization, its recognition, and our advocacy and analyses shared with certain government bodies.

Outreach and Strengthening Our Analyses

In terms of knowledge exchange, the year was marked by renewed connections with several partners in the field, as well as new alliances. Collaborations made possible through research partnerships, reflection days, and conferences in Montreal and across Quebec have allowed us to solidify our knowledge and enhance our understanding of emerging issues. Furthermore, workshops in our communities and our participation in various collaborative forums have made us aware of the diversity of emerging health issues, especially those often excluded from conversations and analyses.

Important Internal Reflection and Discussions

In addition to these accomplishments, several moments of collective intelligence took place with our board members and some dedicated volunteers to discuss our strategic development, organizational health, and change management.

REPORT OF THE BOARD OF DIRECTORS



The Board of Directors met five times this year and the main points of the discussions revolved around succession in the Board of Directors, the financial management of the organization and strategic development issues.

Regarding our priorities adopted at the 2022 AGM, this year we benefited from several skills-building activities for the team and its board with workshops on team consolidation, membership, change management; and this within the framework of reflections surrounding our strategic development. In addition, the team and the board worked closely together to prepare for the important transition that was taking place for the Executive Director position and the organizational restructuring marked by the creation of a new position of Program and Advocacy Coordinator.

The Human Relations Committee – Organizational Transition

BLACK WOMEN AND BREAST CANCER: RACIALIZATION OF A DISEASE

The project which started in May 2022 and ended in June 2023 aims to conduct a (first) state of knowledge on the situations of Black women with breast cancer and their caregivers in Quebec, by studying the socio-environmental determinants and analyzing their dynamic interrelationships at five key moments: prevention, screening/diagnosis, access to care, treatment/convalescence and aftermath (remission, aggravation, recurrence or death). Based on a large-scale literature review and interviews with the first persons concerned and their families, this exploratory research will ultimately allow the partnership team to propose avenues for reflection and specific actions in terms of prevention, support and follow-up, and to develop advocacy aimed at decision-makers, researchers and institutions, all from a feminist, intersectional, anti-racist and environmental perspective.

The central co-decision point in this project was the Supervisory Committee. Composed of prof. Gina Thésée, co-investigator Tya Collins, 1 representative from our organization (Anney), Two research officer Samia Dumais and Camessarde Rosier Laforet and the development officer from the Université du Québec à Montréal (Lampron). the SC met 10 times to oversees the collective implementation of the project, from its inception to the production of final documents. The team worked with dedication for the scientific quality of the project and the tools developed. We were fully involved in this research based on our knowledge of breast cancer, community health and the environment, and contributes fully to the definition of the research objectives, the construction of tools and the identification of specific and common courses of action. A literature review has been conducted, marking the completion of the initial phase of this project. BCAQ plans to conduct a search for opportunities and funding to develop public education tools and infographics based on the knowledge mobilized through the wonderful work of Samia and Camessarde.

More than just a first phase of collaboration, a moment of sisterhood within the framework of this project that we will not forget.

CANADA'S UPDATED ALCOHOL DRINKING GUIDELINES

One issue that many members raised with us this year was around the Update of Canada's Low-Risk Alcohol Drinking Guidelines: Final Report for Public Consultation from the Canadian Centre on Substance Use and Addiction in August 2022. The new guidelines say that no level of drinking is without harm and recommends drinking two alcoholic drinks a week or less. A surprising number of members spoke to us regarding the guidelines, wondering why that had drastically changed and underscored the feelings of guilt it engendered particularly for those who had been through breast cancer.



Few issues have raised such a reaction. Jennifer wrote a <u>blog post to outline how we see the issue</u>, and we still plan on organizing a discussion next year on the question.

THE PLASTIC PROJECT WITH THE CANADIAN ASSOCIATION OF PHYSICIANS FOR THE ENVIRONMENT (CAPE)

Plastics are one of the major sources of exposure to toxic substances and our colleagues at CAPE asked us to collaborate with them to make three videos showing the health and environmental harms created by plastic. The videos were **released in October 2022 and can be viewed on the Youtube channel of BCAO**.

OCTOBER CAMPAIGN: THE ENVIRONMENTAL INJUSTICE OF BEAUTY

In **October 2022**, we partnered with the groundbreaking Environmental Noxiousness, Racial Inequities and Community Health Project, or the Enrich Project, led by **Dr. Ingrid Waldron**, to promote a social media campaign to build awareness among BIPOC youth and others about the diverse health effects of toxic beauty and personal care products, and the role of white/Eurocentric beauty standards in influencing product use. The campaign had a range of tools in addition to influencers, lived experience experts and activists, who live-streamed sessions on the topic.

ENRICH WEBINAR ON THE HEALTH EFFECTS OF TOXIC BEAUTY AND PERSONAL CARE PRODUCTS

On **February 15**, **2023**, Jennifer Beeman, Executive Director, was a panelist with an ENRICH (Environmental Noxiousness, Racial Inequities and Community Health) webinar on The Health Effects of Toxic Beauty and Personal Care Products. The webinar was effective in presenting the interplay between the social and political dynamics at work that create overexposure to toxic products for women and people from racialized communities.





PARTICIPATION IN THE SUSTAINABLE HEALTH SUMMIT AT MUSEUM OF CIVILIZATION (QUEBEC)

January 23, 24, and 25, 2023


Discussions on sustainable health and disease prevention took center stage at this event, which took place at the Museum of Civilization and was organized by the **Public Health Agency of Quebec**. Ariane Métellus, a board member, and Maria Anney, prevention coordinator, attended. BCAQ had the opportunity to address issues of distributive justice in political and sustainable health discussions, the lack of ethnicity and gender-based indicators in health data collection, and the need to move away from an individualized health approach, among other topics.

Recognizing the connections between human health and ecosystem health, addressing issues and alternatives in public health also requires us not to shy away from questions of responsibility for polluting industries when it comes to the health of Quebecers. This event also allowed us to network and establish important connections with groups present in the context of the exploratory project **Mobilize-concert-act: towards an inclusive environmental health network** funded by the André and Lucie Chagnon Foundation.

INTERNATIONAL WOMEN'S RIGHTS DAY - MARCH 8, 2023

We highlighted, this March 8 2023, the International Women's Rights Day, and we rallied around the theme of the March 8th Collective (The March 8th Collective represents over 700,000 women in Quebec, including those from autonomous women's groups and trade unions), which had the theme this year: Feminist Resistances! For BCAQ, feminist resistance is rooted in the history of the feminist health movement, in our anger and critiques of the cancer establishment, and in the recognition of our expertise. All of this was mentioned in an excellent conference by our Executive Director Jennifer Beeman entitled "From Anger to Compliance: What remains of a feminist critique of breast cancer."







CAMPAIGN "MY BREASTS AND UTERUS COUNT TOO!"

In March 2023, we were invited to join forces with Moelle épinière et motricité Québec (MÉMO-Qc) to bring attention to the serious health injustices faces by women with disabilities due to the inaccessibility of diagnostic machines, but also medical facilities.

It is hard to believe that the medical machines and facilities could be inaccessible, but the reality is that this is frequently the case. The campaign continued this fall.

WORKSHOP AT MAISON DES FEMMES DE DRUMMONDVILLE - APRIL 18. 2023

We gave a workshop with around fifteen women in a hybrid format. The topic was environmental health, women, and breast cancer: What connections and what solutions.

Through this workshop led by Jennifer Beeman and Ama Anney, we discussed toxic substances and endocrine disruptors in cosmetic products and the environmental injustices of beauty. We then suggested alternatives to identify these toxins and also discussed the essential advocacy work around amending the CEPA (Canadian Environmental Protection Act).

WORKSHOP WITH HALTE FEMMES MTL NORTH - MAY 18, 2023

The "Take Action Against Toxics" project is an education and public awareness initiative about the dangers of toxic substances in consumer products (shampoos, soaps, cosmetics, cleaning products, etc.).

Through this workshop led by Ama Maria Anney, we brainstormed with around ten participants from the women's center on strategies to advocate for stricter government regulations and compel industries to stop using toxic substances in their products.



We also explored how to identify suspicious chemicals in the home and provided a framework to understand the health risks. In a cheerful atmosphere, we exchanged practical tips and safer alternatives to reduce our exposure to toxic substances present in everyday products.



WORKSHOP WITH THE CENTRE MULTIETHNIQUE DE QUÉBEC ON BREAST CANCER EDUCATION AND PREVENTION – JUNE 28, 2023

On June 28, 2023, we gave our workshop on Breast Cancer Education and Prevention to **34 participants** at the Centre multiethnique de Québec. This was one of the first workshops to integrate the research on breast cancer and Black women into the content and it highlighted the extent to which there are still not adequate resources and recommendations to refer Black women to regarding breast cancer risk.













STRENGTHENING TOXICS REGULATIONS AND BILL S-5

For BCAQ, reforming toxics regulations in a manner that centers the multiple, greater systemic harms of toxic exposures on marginalized and racialized communities, is central to breast cancer prevention. This is why we have been fighting for years for toxics regulations under the Canadian Environmental Protection Act to be strengthened. And with the introduction of Bill S-5 to the House of Commons, this fight was central to our work all year.

Our CEPA Mobilization Committee played a central role in organizing our members and partner groups to get involved to make our voices heard with our members of parliament.

Jennifer Beeman was active with the **Coalition for Action on Toxics** to work on strategy, op-eds, briefs and letters to government leaders. A major part of this work occurred between September and December 2022.

WORK OF BCAQ CITED IN THE HOUSE OF COMMONS

On Tuesday, **October 18, 2022**, Bloc Québécois environment critic, **MP Monique Pauzé**, in a detailed speech on the importance of Bill S-5, spoke about Action cancer du sein du Québec and our work to mobilize and involve women's groups in Quebec in the House of Commons.





MEMBERS AND PARTNERS MOBILIZATION TO "CALL YOUR MP"

Bill S-5 was introduced in the House of Commons on **September 28, 2022**, but the Bill required significant strengthening for it to be able to significantly improve the current regime regulating toxic substances. The CEPA Mobilization Committee, coordinated by Ama Maria Anney, met



several times to establish a strategy for mobilizing our members and encourage them to contact their MPs to ask for the strengthening of Bill S-5. A series of activities were organized in November to concretize this action.

• MP Engagement Training Sessions

With the **David Suzuki Foundation** and the **Coalition for Action on Toxics**, we organized training sessions on MP engagement where skilled trainers took us the the basics of talking with our federal elected officials.

• Videos on the Effectiveness of MP Engagement

Françoise David, Nancy Guberman, Ama Maria Anney and Julie Raby, from Relais-femmes, all created videos to demystify the process of getting in touch with your deputy. As Françoise David said, elected official are there to listen to their constituents. It's their most basic job.

Tools for contacting your MP

We prepared model letters, **information sheets and tools** to find to contact your deputy to make it as easy as possible for people to engage their elected official. The tools were shared through our newsletter and social media.





NOVEMBER 22, 2022: WE MOBILIZE!

Nancy Guberman and Ama Maria Anney coordinate a drop-in site at the Maison-Parent Roback with computers, tools and volunteers to help people contact their deputy on the importance of strengthening bill S-5. We also had a virtual drop-in space through zoom. It was wonderful to see our members and partners committed to issue and wanting to participate in making Bill S-5 stronger. About **50 people** (representing organizations for some of them) contacted their deputy.

BRIEFS TO THE ENVI COMMITTEE OF THE HOUSE OF COMMONS ON STRENGTHENING BILL S-5

At the beginning of November 2022, Bill S-5 was sent to the ENVI committee (The Standing Committee on Environment and Sustainable Development) for study and amendments by the members. This was a critical moment for us because this is the point at which a bill can be strengthened or weakened. We contributed to three briefs that were submitted to the committee in different ways.

The <u>Coalition for Action on Toxics submitted a detailed brief</u> demonstrating the need for significant amendments to the bill. <u>Breast Cancer Action Quebec</u> <u>wrote an intersectional feminist brief</u> that showed the links between toxic

substances and the health of women and people with an ovarian reproductive system and the necessary amendments to the bill. Ten other major women's associations signed onto our brief.

We helped researchers from CoPEH Canada turn their research report on toxic substances in menstrual products into a brief with important recommendations for amendments that was submitted to the ENVI Committee as well.





APPEARANCE AT THE ENVI COMMITTEE OF THE HOUSE OF COMMONS

On **December 6, 2022, Jennifer Beeman and Lise Parent**, former longtime Vice President and scientific advisor appeared at the ENVI committee to present the amendments BCAQ was proposing and answer the questions of committee members.

THE KEY ROLE OF THE COALITION FOR ACTION ON TOXICS

Our participation in the Coalition for Action on Toxics was central to our advocacy work for strengthening Bill S-5.

The Coalition is made up of representatives from the Canadian Association of Physicians for the Environment, Ecojustice, Environmental Defence and Breast Cancer Action Quebec. A representative from the David Suzuki Foundation also participates in the work. The members are highly complementary, despite major differences in area of expertise, size and funding, geographic location, organizational cultures. The members work in a highly efficient and coordinated manner, sharing expertise and allowing the group to always identify the



next best move during the legislative process to make to strengthen Bill S-5. The Coalition has the good fortune to be coordinated by Heather Harding who keeps the work in track and moving forward in addition to putting together the funding for the members.

LThe Coalition produced an extensive document on amendments to Bill S-5 that included proposed legislative text for each amendment as well as an important briefing note explaining the needed amendments. It also issued three press releases at key moments in the process and the joint brief submitted to the ENVI committee for study. All group members appeared before the ENVI committee.

BCAQ was responsible for the translation of documents. All documents must be available in both official languages before being distributed to members of parliament.

Explorations and Important Dialogues

EXPLORATORY PROJECT MOBILIZE - COORDINATE AND ACT: TOWARD AN INCLUSIVE ENVIRONMENTAL HEALTH NETWORK

This ongoing initiative aims to lay the groundwork for creating a collective movement with the goal of advocating for structural changes on **environmental health** issues. The objective is to reduce the risks of many diseases that disproportionately affect women and marginalized individuals in Quebec, from a community prevention perspective.

The specificity of our organization's actions, situated at the intersection of three movements (community health, environment, feminist group), required us to align the expertise of our sector to meet the needs of our communities. These collaborative efforts have always been possible due to our presence in several networks and collaborations. However, more time and funding were needed to continue our reflections on the creation of a Ouebec coalition in environmental health.

BCAQ operates within a large network of community groups serving populations facing environmental health challenges. These groups have clearly expressed the need to come together to advocate more strongly, support their respective actions, and share knowledge and practices. **The challenge lies in the capacity of these organizations to transform this latent network** into a formal network that wants to work together and can dedicate time and resources to this end.

With this in mind, we initiated a **dialogue with the André and Lucie Chagnon Foundation**, allowing BCAQ to begin thinking about the steps and actions to ignite a mobilizing momentum in community and environmental health. This reflection led us to internal reflexivity, documenting ways to decentralize issues, and entering partnerships authentically, intersectionally, and decolonially. We started mapping key groups, monitoring emerging issues in community and environmental health, and establishing contacts with non-traditional partners.

Our initial intention was influenced by an intersectional lens. While we had the support of groups traditionally close to BCAQ, to move towards a more inclusive network, we needed to take the time to also change our processes and examine our networking and collaboration habits. **Through these ongoing battles, the often-forgotten individuals and advocacy groups, whose voices are marginalized and silenced**, remain the citizens concerned, isolated, and with limited resources to be heard. Social justice cannot be discussed without including health and environmental justice, and it is essential that this work be done from an intersectional perspective that considers multiple forms of oppression and centers around the voices and realities of marginalized individuals.

Explorations and Important Dialogues

The Dialogue phase of this initiative allowed BCAQ to implement preliminary steps toward creating an inclusive network. This exploratory period involves engaging in reflective and knowledge mobilization around informed mobilization practices/processes and participatory approaches; identifying and bringing together partners around relevant and unifying issues; and collaboratively determining the form, content, and objectives of a sustainable collaboration.

This poster summarizes in 10 steps the questions we are asking ourselves and the compasses that support our exploratory year:


- University of the Streets Cafe on how Racialized activists are transforming environmental struggles, March 28, 2023
- PARR Group Conference "Burning the fuse at both ends: exploitation of the knowledge and networks of racialized researchers." Creation of communities of practice in partnership research", April 13, 2023
- Center for community organizations (CoCO) on anti-oppression, social change in Québec, and building collective leadership, May 18 and 19, 2023

This preliminary work should allow us to continue engaging with groups representing individuals at the intersection of oppressions, attending important workshops, questioning the nature of mobilization mediums (Hub, coalition, virtual platform, etc.), organizing an authentic conversation panel, illustrating our reflective process in vignettes; actions that will be described in next year's annual report. We will also be able to submit a multi-year funding request to consolidate our team and materialize the mobilizing project.

BCAQ has initiated steps to engage with several provincial ministries, provincial government bodies, and their teams. We have also established meaningful connections with parliamentary allies from Québec Solidaire. The Strategic Development Coordinator has invested several hours in these initiatives. This effort has borne fruit, leading to meetings with a representative of the Secretariat for Women's Issues and representatives from the Ministry of Health and Social Services this year, allowing us to share our analysis on breast cancer prevention and assert our position within the feminist community in Quebec.

STRATEGIC REFLECTIONS

Strategic Development



In addition to our educational and advocacy work, internally, we were very active in moving forward with our Strategic Develop Plan. Ama Maria Anney coordinated this important work (in september 2022) with our Strategic Development Committee and Consultant Marlo Richie Turner of **Social Impact Consulting**.

The team of workers, some activists, and the Board of Directors took part in several skill-building and reflective workshops with Social Impact Consulting. These collective moments aimed to strategize change management, membership, and internal operations.

On February 18, 2023, BCAQ had the presence of several activists, workers, and board members for the first strategic meeting of 2023 to assess the ongoing initiatives and outline the organization's next steps.

We prioritized a friendly atmosphere by starting discussions with team-building activities before addressing questions related to results-based management for our learning organization. Collectively, we celebrated all activities, collaborations, and advocacy efforts carried out with resilience despite the challenging pandemic years we have overcome. Subsequently, we engaged in discussions about future directions, the announced transition in general management in January 2023, and the needs for consolidation and restructuring.

STRATEGIC REFLECTIONS

Transition and Restructuration

BCAQ experienced a pivotal moment in its history. Indeed, Jennifer Beeman, Executive Director for 9 years, announced in February 2023 her intention to step down from her position. The role of Executive Director is a crucial one within our organization. Therefore, it was important for our organization to propose a plan that would allow us to ensure effective succession and continue our mission. Transition planning was quickly organized with the Board of Directors and, more specifically, an HR-transition committee.

A plan was developed, and the implementation steps were integrated into the organization's strategic priorities. It is important to note that BCAQ chose to proceed with an internal recruitment (Internal transition plan available upon request).

Several hours were also devoted to Phase 1 (2022-2023) of this organizational transition plan:

- Formation of an HR Committee to oversee the process
- Orientation and succession plan
- Exploration of best practices in the field
- Reflections on the issues surrounding BIPOC leadership (a board member and two workers attended a webinar on this subject)
- Considerations regarding team restructuring
- Communication plan to announce the transition

COMMUNICATIONS

OUR ONGOING MONITORING AND DOCUMENTING OF BREAST CANCER RESEARCH AND TRENDS

BCAQ monitors new breast cancer research and prevention policy that allows us to see emerging trends. The quantity of important research on carcinogens and endocrine disrupting chemicals continues to grow. As does the research on the quantity of toxic substances in personal care products, particularly those aimed at racialized women. Research that indicates that breast cancer test and therapies are less effective on racialized women is a very disturbing trend that we have our eye on.

INFORMATION AND REFERRAL

We had a significant decrease in the number of requests for information or referrals compared to the previous year. We never get a large number of requests, but this past year only saw 24 requests for information via email and 11 phone calls. We hypothesize that the previous year saw a particularly high number as we were coming out the pandemic and people were looking to access services that were still overwhelmed. During our workshops, we were also able to guide several participants.
